Segal Family Foundation partners with Myriad USA to facilitate tax-efficient giving. All donations are formally made to the SFF Proximity Fund, a donor-advised fund managed by Myriad USA.

You may make three types of donations:

- To the SFF Proximity Fund itself, leaving Segal Family Foundation free to assign monies as it sees fit to further its overall objectives.
- Toward a specific theme (e.g., sector, geography, etc.), with Segal Family Foundation determining the end recipient(s) in line with the established parameters.
- To an organization that is part of [Segal Family Foundation's portfolio](#).
 - Please note that these donations are subject to the end recipient passing through Myriad USA's diligence screening. In the event that such diligence is unsuccessful, we will work with you to identify an alternative recipient or to return the funds to your account.

FAQs

Are there fees charged on donations?

Segal Family Foundation covers the cost of all management fees that are paid to Myriad USA so that 100% of your donation will go directly to visionary organizations in Africa.

Are donations made from the United States tax-deductible?

Myriad USA is a U.S. public charity within the meaning of Sections 501(c)(3) and 509(a)(1) of the Internal Revenue Code. Donors may claim the maximum tax benefits allowed by U.S. tax law for their contributions.

Myriad USA does not provide legal, tax, or investment advice and encourages all donors, fundholders, and fund advisors to consult with their professional advisors to determine the best options for their individual situations.

Are donations made from abroad tax-deductible?

Myriad USA is a member of the [Myriad Alliance](#), whose members provide world-class philanthropy services for cross-border giving from a variety of locations around the world.

Donors based in Belgium, the Netherlands, Luxembourg, France, and Denmark can make tax-deductible donations through Myriad Europe. Donors based in other European countries, Australia, Canada, or New Zealand can be assisted by the Transnational Giving Europe Network, Myriad Australia, Myriad Canada, and the Gift Trust.

To make a donation from outside of the United States, contact our team at equitablegiving@segalfamilyfoundation.org. We will work with the Myriad Alliance to determine whether there is an appropriate philanthropic vehicle for you.

Why am I making a donation payable to Myriad USA and not Segal Family Foundation?

Funds hosted at Myriad USA are not legally registered entities. While your donation will be payable to Myriad USA, the funds will be allocated to Segal Family Foundation's donor-advised fund (the SFF Proximity Fund). Since Myriad USA is a Section 501(c)(3) public charity, donors may claim the maximum tax benefits allowed by U.S. tax law for their contributions.

What is the EIN or tax number for Myriad USA?

What due diligence process does Myriad USA follow when making a grant from the SFF Proximity Fund?

Myriad USA vets all of its grantees and nonprofit partners using a due diligence questionnaire. Reputational checks are carried out through our networks of local partners and consultants. In addition, the names of trustees, directors and key employees of grantees are checked against the lists of individuals and organizations identified by the U.S. government and the United Nations as associated with terrorism.
